**Re: Request to Dismiss charges against Marc Fishman in case 6293/2018 due to police misconduct, falsified arrest reports, disability discrimination, abuse of power by former arresting officer Lane Schlesinger as reported by Atty General Latisha James in OAG matter 1-793542917 5/24/2024 misconduct report**

**Dear Honorable Judge Williams:**

**I write as a supporter of parental rights for you to kindly drop charges against a dedicated, loving, caring disabled father of four kids, named Marc Fishman.**

**Marc Fishman was wrongfully convicted of violating an unserved order of protection during prepaid , preconfirmed and prescheduled visitation with his children on 12/15/18. Mr. Fishman was accompanied by his court ordered disability aide Isabel Bolivar and his court ordered supervisor, Ann Elliot on 12/15/18 for the prepaid \$500 supervised visit per the 22 page visitation order.**

**Instead of honoring the visitation order and enforcing its terms, former police officer Lane Schlesinger falsely arrested Mr. Fishman for not violating an oral order of protection with no distance to stay away from protected property during supervised visits.**

**Then now disgraced former officer schlesinger withheld the exonerating police radio, video and audio from Mr Fishman and the jury showing Mr fishman did not go on protected person**

**property and withholding recorded video comments by lane schlesinger that no crime was committed. Former officer schlesinger falsified the arrest report by stating “ unknown” to the question of is supervisor present. Officer Schlesinger left blank the section of arrest report where it stated “ is police video and audio available.” Ontop of all of this misconduct, former officer Schlesinger denied Mr Fishman’s disability aide from assisting Mr. Fishman , who is cognitively and hearing impaired with communicating the terms of the visitation order. Officer Schlesinger physically blocked, Mr Fishman’s communication aide from entering the question room at police station even after Mr. Fishman showed officer schlesinger his implant cards for his two Neurostimulators indicating Mr. Fishman needs communication assistance for his traumatic brain injury and post concussion syndrome.**

**Not only did district attorney Miriam Rocah state the verdict was defective under 310.50( on 11/12/21,) for wrongfully convicting Mr. Fishman for both attempted violation of order of protection and completed violation of protection order for not going on exwife property, but Da Rocah acknowledged her office never received the exonerating video from police precinct and former officer schlesinger in violation of enhanced discovery laws.**

**Given the gravity and scale of the Attorney General misconduct report designating officer Lane Schlesinger a “ pattern misconduct and abusing police officer” who “ falsified evidence” in multiple cases, the County Court must do the right thing and dismiss charges against Mr. Fishman immediately.**

**Mr. Fishman has been wrongfully denied access to his four children for over 1669 days due to wrongful conviction and endless orders of protection.**

**It is time to reunite Mr. Fishman with his four kids and end a persecution based on a pattern abusing former police officer, Lane Schlesinger.**
